



4.3 Hostels

ICT Marathwada has rented residential flats, which are currently used as Hostels. In the same premises in separate wing Girls Hostel arrangement is made. At present, these Hostels can accommodate 96 boys and 50 Girl students. Guest House facility and Wardens residence is also located in the same building complex. Wardens manage all the affairs of the hostel and are assisted by hostel office staff. Laundryfacilities and housekeeping is arranged for.

4.4 Transportation

The Institute provides bus transportation from the hostel to the Institute and back to all the students of Int. M. Tech. program.

5 Process of Allocation of Hostel Accommodation

- Hostel No. 1 is allotted to Girls from all years of Integrated M. Tech course. Girls from other courses will be accommodated subject to vacancy. Hostel No. 2 is for Boys mainly from the First Year M. Tech Integrated course. All the hostels are unaided and maintained by the Institute.
- 2. Bus Conveyance is arranged from Hostel to reach ICT, MARJ,Campus which is about 3.5 kilometers away.
- 3. Only bonafide full-time students of ICT MarJ are entitled for hostel admission and bus convenience.
- 4. Admission will be offered on merit basis. Preference will always be given to out-station students who come from places beyond the limits of Jalna. As a proof of stay beyond the limits of Jalna, they are required to upload scan copies of ration card/ Aadhar card and school-leavingcertificate. Any false representation in this regard will be strictly dealt with.
- 5. Student who have taken admission to ICT can register on-line through ICT log in portal (<u>ictmumbai.co.in</u>). Students need to upload a residence proof, a medical certificate from his/her family doctor (which clearly mentions about chronic/critical health conditions or allergies, if any).

- 6. Hostel authority will approve the form and take a call on the admissions to the hostel depending upon the availability of seats based on need.
- 7. Students must confirm the hostel admission by paying the required fee ICT, MarJ Hostel account.
- 8. The Warden of the respective hostel has all the rights to change/transfer a student from one room to other within the hostel for convenience of the administration. Also, every year the student may be shifted from the accommodation provided in earlier year.
- 9. In case of the year-drop, the candidate will have no claim for hostel accommodation and will have to vacate the hostel. Readmission for such student on clearing the year-drop will not be guaranteed.

5.2 Hostel Mess:

It is compulsory for all hostel students to join the Hostel Mess. The mess charges includes breakfast and two meals a day. All the Mess members are required to pay to ICT, MarJ Hostel Account Rs. 18,000/- towards advance mess charges for Trimester 1. A deposit of Rs. 5,000/- is required to be paid at the time of joining of Mess which will be refunded (part) only if annual Mess expenditure is less than Rs. 25,000.
